#### C. In-Person Registration:

It is mandatory to attend the registration in-person (physical) at IIT Gandhinagar. Necessary information shall be updated regularly at <https://iitgn.ac.in/>. Biometric verification would be done during registration, using the data captured during JAM 2023 examination. Avoid any coating (ink, mehendi, henna, or tattoo) that can hamper biometric verification. Candidates should bring all relevant certificates/marksheets as per the list specified (Annexure VIII) in the Admission Brochure and any other documents specified by the Institute.

#### D. Category/Disability Certificates:

- (i) EWS (Economically Weaker Section) and OBC-NCL (Non-Creamy Layer) applicants are required to produce valid category certificate in prescribed formats (as given in the JAM 2023 Brochure) issued on or after **April 1, 2022**. SC/ST applicants are required to produce valid category certificate in the prescribed format.
- (ii) OBC-NCL category to which the applicant belong must be included in the list of Other Backward Classes issued by the Central Govt. of India in its latest notification failing which the admission of applicant will be cancelled.
- (iii) Persons with Disability (PwD) candidates shall have to appear before a Medical Board duly constituted by IIT Gandhinagar, if needed. Reservation is applicable only to those who have at least 40% physical impairment. The PwD candidates must produce the Disability Certificate, issued by a Government Medical Board.

#### E. Provisional Admission:

- (i) You must comply with the Eligibility Requirements (ERs) and Minimum Educational Qualifications (MEQs) as mentioned in the Admission Brochure at <https://jam.iitg.ac.in/>. Failure to meet ER and MEQs will lead to *suo moto* cancellation of admission.
- (ii) Your admission is **PROVISIONAL**, subject to production of all required original documents during document verification. The selection may be cancelled at any point if the candidature is found to be against the ordinances, rules and regulations of the Institute.
- (iii) Your admission will be regularized after verification of all required original documents at the time of your reporting to the Institute and subject to satisfying all eligibility conditions stated in the advertisement for admission.
