(iii) The committee will organize a meeting with the complainant within five days of the receipt of the complaint, but not later than a week in any case.


(iv) At the first meeting, the committee members shall hear the complaint and recorded her allegations. ~~The~~ after receiving the complaint in writing/ email.

(vi) In the event the complaint does not mean an offence of Harassment, the same would be dropped after recording reasons thereof. In case the complaint is found to be false, the complainant shall, if deemed fit, be liable for appropriate disciplinary action by the committee.

(vii) Internal Complaints committee meet at least twice in a academic session but in case of any emergent situation or if the situation demands so, the members shall not hesitate to meet any numbers of times for the sake of the institution.


